# FROM THE MAA-SE SECTION REPRESENTATIVE 

## INTRODUCING EMILY HYNDS

Greetings colleagues and friends! I began my service as your representative to the MAA Congress in August of 2021 when the Congress gathered virtually just before MathFest. This past March, I thoroughly enjoyed seeing so many of you in person in at our section meeting at Berry College. I am now looking ahead with great anticipation to my second Congress meeting at MathFest in Philadelphia this year. I am very grateful we will likely be able to gather in person!

The 2021 Congress meeting was led quite ably by our very own section member, Tim Chartier, who served as Chair of the Congress. Our first day agenda included a report from the AIMS (Advancing Inclusion in Mathematical Sciences) task force, a budget update, a discussion of widening MAA membership, information on elections, and a report by Francis Su representing the Task Force on Understanding and Documenting the Historical Role of the AMS in Racial Discrimination. The second day agenda included an update from MAA President, Jenny Quinn, election results, and a thorough update from various MAA staff members on the MAA strategic plan.


While the pandemic affected many of the plans of the MAA, as it did for all of us, it also provided opportunities for creativity and new modes of communication and content delivery. Consider the thoughtful words of MAA Executive Director, Michael Pearson.
"I hope you'll also be proud of the ways in which MAA has adjusted to support our community and continues to champion change. The MAA will continue to focus on our mission, core values, and vision. During the last year, we have all been called to reckon with historical barriers affecting participation in mathematics. One of our core values is inclusivity. Progress can only come through community engagement and action. Our virtual Diversity, Equity, and Inclusion (DEI) programming represents early efforts on this front.

There is much room to improve. We must all engage honestly with our past to advance equity, diversity, and inclusion within the MAA and in our community.

Although it was a year filled with pain and uncertainty, it gave us space to come together, sharing our insights and learning together, gaining strength and resiliency through community. The discussions I followed on MAA Connect reminded me that MAA is our members, and it is through our collective efforts that we advance our mission, values, and vision."

The MAA continues to have multiple opportunities for membership types and, through membership, access to programming and published materials. In addition to the old favorites, the MAA is pleased to announce the new MAA/AWM/NAM Section Lecture Series and the new OPEN Math Workshop Series. The lecture series will complement the George Polya lectureship, bringing excellent expositors and a diverse group of speakers representing early-career mathematicians. The workshop series will expand access to high-quality faculty professional development by eliminating the costs of travel. OPEN Math will support over 40 intensive online professional development workshops for undergraduate math instructors.

Other ways to get involved and connect with MAA members from across the country include the participation in any of the 17 Special Interests Groups of the MAA (SIGMAA) and service on national committees. The MAA is currently working to fill openings on these committees that make important recommendations and policies for the organization. ## SECTION MEETING REPORT

## $101^{\text {ST }}$ ANNUAL MEETING

The 101st Annual Meeting of the Southeastern Section of the Mathematical Association of America—our Centennial Meeting—took place March 10-12, 2022 at Berry College in Mt Berry, GA. Many fine folks worked many hours to prepare for this event, and you can find acknowledgment of their work elsewhere in this newsletter. There were 219 pre-registered attendees: 119 post-secondary faculty, 3 K-12 faculty, 14 graduate students, 78 undergraduate students, 1 K-12 student, and 4 "other." 34 of those pre-registered guests attended remotely. Our program included 5 invited lectures, 50 contributed papers, 19 undergraduate talks, and 15 undergraduate posters. One of our invited lecturers, Dr. Tim Chartier, gave his talk virtually (pre-recorded), and you can still view it online: https://youtu.be/6tGmw9cF-tl.

The attendance this year was down slightly from previous in-person meetings, but those who attended were very happy to finally be seeing each other in-person.

A few personal highlights from the meeting included:

- The opportunity to host Marissa Loving (soon to be starting a new position at UW-Madison) as part of the MAA's new Section Lecturer program. Marissa was our AWM-MAA Section Lecturer for this year, and she talked on her research on topology. As with any good topology talk, there were many interesting pictures!
- Seeing a new idea-inviting career-oriented speakers for our Distinguished Lectures for Students-turn out well. We hope this may become a new tradition for our Friday morning student lectures.
- Watching another fun Math Jeopardy final, in which the home team—Berry College-took home the 1st place trophy.
- Hearing a number of great talks on the occasion of the 100th anniversary of MAA-SE, including one where Jeff Knisley closed with this exhortation: "Our section continues to thrive due to great leadership, our outreach to undergraduate and graduate students, and the motto that seemed to define us from the beginning-Anyone Interested in Mathematics is Invited to Attend. As our motto continues to drive us, we appear to be heading in the right direction as we enter our next 100 years."

I look forward to seeing many of you at our 102nd Annual Meeting in Conway, SC in March, 2023. Anyone interest in mathematics is invited to attend!

# 2022 MAA SOUTHEASTERN SECTION AWARDS 

DISTINGUISHED SERVICE AWARD (PRESENTED BY JULIE BARNES)

It's an honor to serve as Chair of the Section Service Award Committee. I want to thank the members of the Committee for their service. They are Jeff Knisley (East Tennessee State University), Emily Hynds (Samford University), Jeff Denny (Mercer University), Antara Mukherjee (The Citadel), Todd Lee (Elon College), and Jessie Hamm (Winthrop University). Our committee has representation from all five states in the section as well as past award winners.

This year's MAA Southeastern Section Distinguished Service award winner has contributed greatly to our section meetings in multiple ways over many years. She served as a state director for two years, was the section secretary for 6 years, and was an MAA Liaison for 5 years. In addition, she organized one of our meetings locally, was on the site selection committee for 3 years, and hosted section officers' meetings multiple times. This person also has been involved with undergraduate student activities at our meetings by organizing the undergraduate student poster session, serving as a judge for undergraduate posters, and serving as a session chair for undergraduate paper sessions.

In addition, she is very active in her local university, participating in a wide variety of committees and taking on many leadership roles.

DISTINGUISHED TEACHING BY A BEGINNING COLLEGE MATHEMATICS FACULTY MEMBER (PRESENTED BY JULIE BARNES)
I'd like to thank all the committee members this year for their work and dedication to the section. This committee consisted of all 5 state directors as well as the previous 3 award winners.

This year's teaching award for a beginning faculty member is frequently described by students as the best teacher they have ever had. Peers say that her classes are thoughtfully structured with supportive learning opportunities, especially for students with math anxiety. Students are provided with clear expectations, a huge amount of practice, support, and repeated guidance on how to solve various types of problems, as well as opportunities to reflect on their learning and take corrective action as needed. While doing group work, students are deepening their understanding of the material.


Of particular note is this award winner's contribution to the multi-section precalculus course, where many instructors are using materials that this person created for a flipped classroom format. Also, many inexperienced graduate students and fixed term faculty see this person as a great teaching mentor. Overall, this person's work helped reduce the DFW rates in precalculus from $33 \%$ to $6 \%$. In addition, the current precalculus cohort is seeing greater gains in the follow up Calculus 1 course.

At the university level, this person has co-led a workshop run by the Center for Teaching and Learning entitled "Teach Students to Problemsolve, Not Answer-get". She also took on the leadership of a Faculty Learning Community (FLC) for active learning.

I am pleased to present the MAA Southeastern Section Award for Distinguished Teaching by a Beginning College Mathematics Faculty Member to Dr. Toyin Alli from the University of Georgia.

## DISTINGUISHED TEACHING AWARD (PRESENTED BY JULIE BARNES)

I'd like to thank all the committee members this year for their work and dedication to the section. The committee consisted of all 5 state directors as well as the previous 3 award winners.

This year's Distinguished Teaching award winner is an outstanding educator, undergraduate research advisor, program developer, and resource for other faculty. As a teacher, she is constantly working to improve already exemplary teaching abilities. Most recently, this person implemented standards-based grading to help students master proof writing skills without worrying so much about each grade. This person has also developed inquiry-based assignments that allow multiple means of engagement by students; this person's work was recognized by a grant-funded program that helps postsecondary campuses become more welcoming of students with learning and attention differences.

On the other end of the spectrum, the dean of the Honors program at this person's university describes this person as one of the most talented, effective, and technologically innovative classroom teachers. Outside of class, this person has mentored over 30 undergraduate students on research projects while still teaching a 3-3 load. She is also actively involved in a variety of programs at the department, college, and university level leading workshops, developing programs for students with weak backgrounds, and assisting other faculty as they transitioned to online learning during the pandemic. THE 2023 SOUTHEASTERN SECTION AWARD FOR DISTINGUISHED TEACHING BY A BEGINNING COLLEGE MATHEMATICS FACULTY MEMBER

Nominations for the 2023 Southeastern Section Award for Distinguished Teaching by a Beginning College Mathematics Faculty Member are now being accepted.

Brief Description: The MAA Southeastern Section (MAA-SE) established this award to honor beginning college or university faculty whose teaching in the Section has been extraordinarily successful and whose effectiveness in teaching undergraduate mathematics is shown to have influence beyond their own classrooms. An awardee must have taught full time in a mathematical science in the Southeastern Section for at least two years, but not more than a total of seven years in any collegiate institution. Each year at most one college or university teacher is to be honored with this MAA-SE section award. Nominations for the award may be made by any member of the MAA-SE section.

A complete nomination packet should consist of a nomination form, a narrative, additional documentation, and letters of recommendation as described below. Please email the completed packet by February 1, 2023 to:

## Eligibility and Guidelines for Nomination

Eligibility: Teaching is intended to include classroom instruction as well as activities outside the classroom, such as working with student groups, preparing students for mathematical competitions, directing undergraduate students in research in mathematics, directing students in the preparation of honors theses, preparing teaching materials used by others, etc.

Nominees must:

- Hold the terminal degree required by SACS to be a full time faculty member in a collegiate institution,
- Be college or university teachers currently in the MAA-SE who have taught full time in a mathematical science in the Southeastern Section for at least two years, but not more than a total of seven years in any collegiate institution. In determining eligibility, we do not count time spent in a postdoctoral position where nearly all the nominee's time was spent on research, and the nominee did very little or no teaching (e.g. three semester courses a year or less), and
- Hold membership in the Mathematical Association of America

Guidelines for Nomination: Nominees for the award may be made by any member of the MAA-SE section.

Nominees should:

- Be recognized as extraordinarily successful in their teaching
- Have effectiveness in teaching undergraduate mathematics that can be documented
- Have had influence in their teaching beyond their own classrooms

Nomination Packet: We require the same materials for nomination as the Henry L. Alder award. A nomination for this award should consist only of the materials requested below, and should not include any other materials, such as curricula vitae or other items.

Nomination Form: A completed Nomination Form is the first part of the packet. Please see the following section of this newsletter for the nomination form.

Narrative: Please describe the nominee's extraordinary success in teaching by providing a narrative of the nominee's background, experience, teaching style, special contributions, other teaching awards, and any additional evidence of the nominee's unusual achievement in teaching. Note especially effectiveness in teaching undergraduate mathematics and influence beyond the nominee's own classrooms. The narrative should be single-spaced in 12 pt font with at least $3 / 4$ inch margins and should not exceed 2 pages.

Additional Documentation: Please submit no more than two pages of further evidence to document the nominee's extraordinary teaching success. This documentation will vary greatly from institution to institution, but may include summaries of peer or student evaluations, comments on teaching, possible increases in numbers of majors in mathematics (with clear evidence of the nominee's substantial responsibility for them), possible student success in mathematics competitions (with clear evidence of the nominee's substantial responsibility for them), success in research in undergraduate mathematics conducted by undergraduate students under the direction of the nominee, development of curricular materials successfully used by colleagues, adoption of the nominee's teaching methods or techniques by experienced colleagues, service as a respected adviser for a student group, etc.

Nominators should bear in mind that the selection committee might view a nomination more positively if it is accompanied not just by carefully chosen testimonials from a few selected students and faculty, but also by reports, comments, and criticism which is representative of the whole spectrum of opinion among students and faculty on the nominee's teaching.

Letters of Recommendation: Please include no more than five letters of recommendation, not exceeding one page each, as follows:

- Two letters from the nominee's present or former students.
- Two letters from the nominee's colleagues (one of whom could be the department chair).
- One additional letter from any one qualified to comment on the nominee's extraordinary teaching success.
